Further to the announcements dated 3 March 2017 and 7 March 2017, the Company wishes to announce the status of the Writ of Summons and Statement of Claim (Kuala Lumpur High Court), Writ of Summons No : WA-22NCVC-91-02/2017 issued against the Company by Amanah Raya Berhad ("Plaintiff") through its solicitor Messrs Mohanadass Partnership.

Subsequent to the receipt of the Writ of Summons and Statement of Claim, the Company had on 17 April 2017 filed its defence against the claim and submitted a counterclaim as follows :-

1. A declaration that the Plaintiff's letter dated 1 September 2015 amounts to an unlawful termination and/or repudiation of the agreement between the parties under the law;
2. Damages in the sum of RM18,651,594.90;
3. Interest at 5% p.a. on the sum of RM18,651,594.90 from the date of the filing of the counterclaim until the date of judgment;
4. Interest at 5% p.a. on the sum of RM18,651,594.90 from the date of judgment until full realisation;
5. General Damages;
6. Damages for loss of goodwill;
7. Aggravated and exemplary damages;
8. Further and/or in the alternative, damages to be assessed;
9. Costs on a solicitor-client basis;
10. All other expenses incurred for the defense against the Plaintiff's claim and prosecution of the counter claim; and
11. Any further relief which the Court deems fit and proper.
